...enforceable unsecured debts and funeral expenses, the expenses of administering my estate.

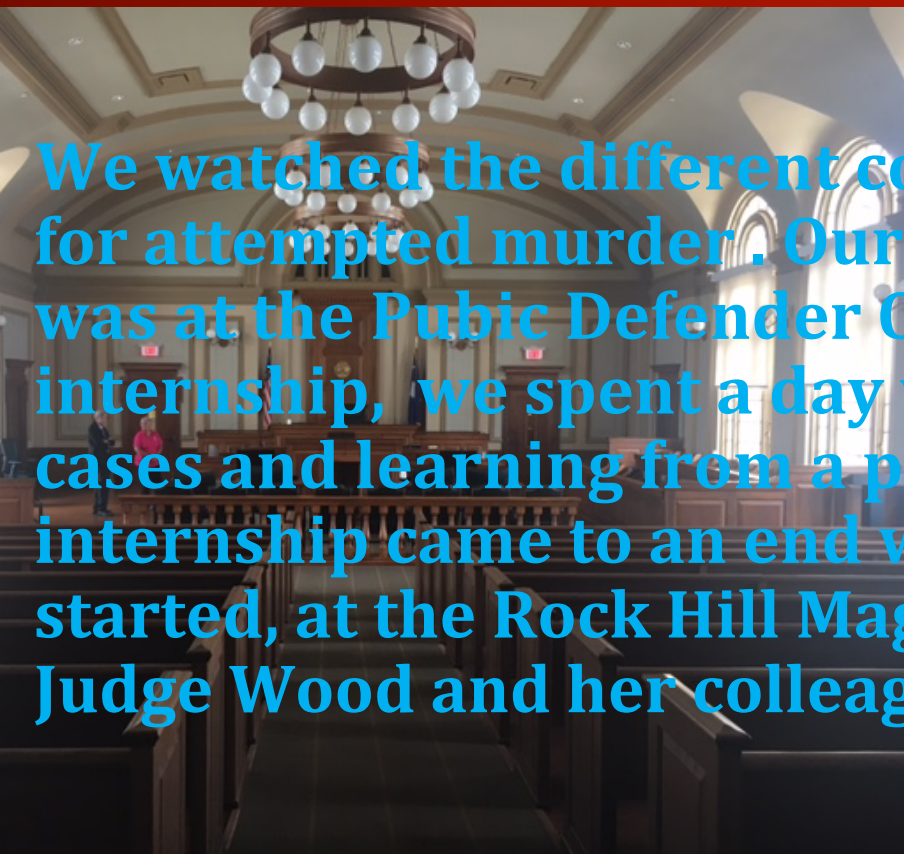
...before other assets are distributed. This clause gives your home, court costs, and hospital expenses.

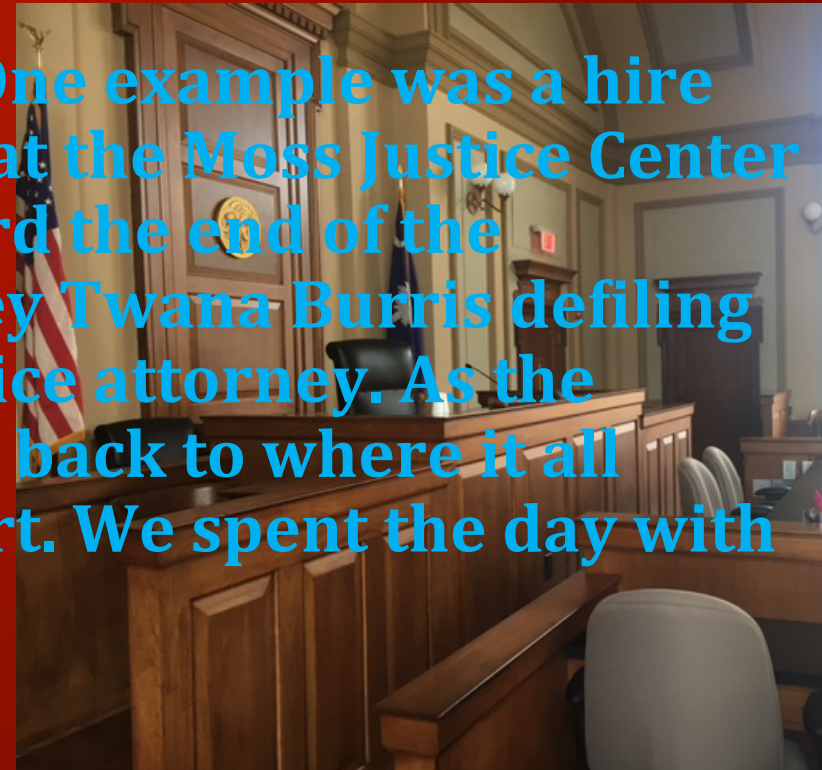
