

## **Rock Hill Schools-Title I Schoolwide Programs**

In 1965, the Elementary and Secondary Education Act (ESEA) was passed under the leadership of President Lyndon B. Johnson. Title I was the largest federal assistance program for our nation's schools. The goals remain the same today as it did in 1965, **to provide a high-quality education for every child.**

The federal government provides funding to states each year for Title I. To receive funds, each state must submit a plan describing what all children are expected to know and be able to do. The plan also outlines the high quality academic performance standards that all children are expected to meet and ways to measure the student's progress. Once the state submits a plan, the federal government releases Title I funds to the state department of education which in turn allocates funds to the individual school districts.

Schools that have a free or reduced lunch population of 75% or greater are required by the federal government to be served as Title I schools.

Each Title I school develops a plan in conjunction with parents and community members that address the specific needs of that school. All students attending a Title I school benefit from the services provided. A copy of each Title I school's plan is available at the school.

### **Parent's Right to Know**

One of the major components of the federal Every Student Succeeds Act (ESSA) is an increased emphasis on parental involvement. As per Title I and ESSA, parents may request information regarding the professional qualifications of their child's teachers, including:

- ☐ Whether the teacher has met state qualification and certification requirements for the grade levels and subjects he/she is teaching;
- ☐ Whether the teacher received an emergency or conditional certificate through which state qualifications were waived;
- ☐ What undergraduate or graduate degrees the teacher holds, including graduate certificates and additional degrees, and major(s) or area(s) of concentration;
- ☐ Whether your child receives help from a paraprofessional and, if so, their qualifications.

## **Curriculum and Assessment**

Rock Hill Schools administer a variety of standardized assessments to its students. SC READY is given to students in grades three through eight for ELA and Math. The SC Palmetto Assessment of State Standards (SCPASS) is given to all students in grades four through eight. Both measure student performance on the state standards.

**For each SC READY test, four overall performance levels will be reported:**

- **Exceeding Expectations**
- **Meeting Expectations**
- **Approaching Expectations**
- **Not Meeting Expectations**
- 

**For each SCPASS test, three overall performance levels will be reported:**

**Exemplary** - The student demonstrated exemplary performance in meeting the grade level standard.

**Met** - The student met the grade level standard.

**Not Met** - The student did not meet the grade level standard.

## **Parent and Family Engagement Policy**

The district along with Title I school in Rock Hill Schools annually develops a parent involvement policy. Parents have the opportunity to provide comments and suggestions concerning changes they wish to make to the school/ district policy.

The draft policy is distributed to families during the first semester of the school year. The draft district parent policy is usually sent home with your child during the month of October. Comments and suggestions for revising the parent policy are received by the Director of Federal Programs. The final district parent policy is then revised after all comments and suggestions are
