SUBJECT: Student Drug Testing - Update

Update to survey and board questions from January business meeting:

- Parent/Student Survey Results from Survey Launched December 2017 Update As of March 8, 2018, 530 parents have responded to drug test survey 64% in favor; 494 students have responded with 54% not in favor
- Testing would take place in a private area with restroom facilities. The specific testing procedures are outlined in the draft rule.
- For the student to have no penalty, counseling must take place
- Not aware of grants to cover cost of drug testing
- The principal and the family are made aware of results; coach will not be made aware unless two or more tests are positive and the student does not follow the guidelines to maintain team status.
- We will provide a draft policy and rule at the April work session, also, we will share a legal opinion from our attorneys related to testing of pre-employment individuals and random drug testing of employees.
- Individuals under the influence or in possession this year: Found to be under the influence/possession on property high school students – 18 This number does not reflect those that may be using on weekends or at night, not under the influence during the school day.
